- Technological** – presentations covering technological aspects of the use of IT in Higher Education Institutions.
- Good Practice** – presentations on examples of applications and deployments of modern technological solutions covering all aspects of the Congress themes in Higher Education Institutions.

The abstract will be published in the Congress Book of Abstracts although you can choose to submit a full paper for publication in the Congress Proceedings Book as well.

The best presentation from the each track above will be awarded.

The submission for the **Research Papers** track should contain both the extended abstract and the full paper.

A submission for the **Technological** track or for the **Good Practices** track may contain an extended abstract only. If you, however, wish to have a full paper published in the **EUNIS 2010 Congress Proceedings Book**, the submission should contain the full paper also.

All submitted papers/abstracts will go through reviewing processes carried out by the Program Committee (at least two reviewers for each paper/abstract). The reviews will support the selection process of those papers/abstracts that will be accepted for their presentation at the Congress as well as the papers approved to their publication in the official EUNIS 2010 Congress Proceedings Book.

All accepted abstracts from all the tracks will be published in the **Congress Book of Abstracts**.

Accepted papers must be presented during the Congress by one of the authors.
